

## ATD-8702 4 Piece Inner Tie Rod Tool Set Owner's Manual





- This tool set allows a quick and easy removal and installation of the inner tie rod without need to dismantle the steering rack from the vehicle
- Tie rod head can be automatically clamped when in use
- Operate with a 1/2" ratchet or a 32mm open end wrench
- 3 interchangeable heads have application ranges of 30-35mm, 35-40mm and 40-45mm
- 1 piece hollow body (370mm long and sectionally knurled) allows for tie rod to pass through center




## INSTRUCTIONS

- 1) Consult your vehicles manual for proper proceedures and warnings pertaining to accessing your particular vehicles inner tie rod.
- 2) Once access has been gained to your inner tie rod, select the correct sized interchangeable head (Fig. 1) and slide it over the tie rod, hex side out, until it meets the tie rod nut at the steering rack (Fig. 2).
- 3) Slide the handle over the tie rod end, and join it to the interchangeable head (Fig. 3). Note the working end of the handle has both a 1/2" drive for a ratchet, or a 32mm hex for a socket or wrench (Fig. 4 & 5).
- 4) Turn the tool counter-clockwise to remove the inner tie rod. Assembly is the reverse of disassembly.
